This product's purpose is as a soil amendment that is a combination of living, beneficial microorganisms that have the ability to degrade a wide variety of organic polymers such as starch, cellulose, chitin and lignin. Can be applied with most conventional product applications. Physical compatibility test is recommended. Agitate or mix prior to applying or blending. To prevent damage to microbes, keep out of direct sunlight. Store in a cool place. Replace cap to container immediately after use.

DIRECTIONS FOR USE

Broadcast spray 48 ounces DgradeR with or without 2 pounds dry spray grade AMS per acre. For agronomic application rates suitable for your crop, geographic area and soil type, consult a trained specialist and apply as needed based on a soil test, tissue analysis and/or according to recommendations in your SoilBiotics Crop Management Plan.
