From the Fields

Growing season is moving right along and we thought we'd share a few bits and pieces we've heard from some of our dealers in the field.

From Nebraska:

Our dealer in Nebraska reports that overall conditions this spring were dry early but improved as planting progressed. He had a customer who accidentally overapplied spring fertilizer and burned the corn seed. After discussing strategy with SoilBiotics, the dealer had the customer use our **DgradeR** in furrow for the corn replant acres. The replant corn came up perfectly.

This same dealer is seeing very good results with SoilBiotics products increasing nitrogen efficiency for in-season applied urea, resulting in less overall nitrogen need.

From Ohio:

One dealer in Ohio reported dry conditions early this spring, allowing for some early tillage. Conditions turned very wet in May and June. This resulted in forage being harvested in wet fields before it overmatured. He stated that the use of SoilBiotics **Soil Boost** humic acid product has resulted in better drainage and soil conditions. No insect or disease pressure so far.

From Arkansas:

Our Arkansas dealer reports that a customer had phenomenal performance with our **Growth Supplement 30** fulvic acid product. He had a 15-acre hay field that was fertilized with poultry litter, then had DuraCor with surfactant applied. First cut yielded 35 bales. The customer then switched to applying DuraCor with SoilBiotics **Growth Supplement 30** and saw second cut yield improve to 95 bales. Quite a success story.

From Illinois & Indiana:

One of our dealers who covers Illinois and Indiana had an Illinois customer with water hemp problems who struggled to kill these weeds with traditional chemicals and surfactants his local co-op supplied. He used **Growth Supplement 30** to help penetrate and increase the kill. His fields are clean, and he is very pleased with what he has seen. He now is a firm believer in the power of **Growth Supplement 30**.

Another customer from western Illinois ran a small test of SoilBiotics products, including **SB Super Sweet, Soil Boost, Growth Supplement 30**, and more. He noticed where he applied these products there was no chemical carryover compared to the issues he saw on the untreated ground.

We had a customer in Indiana use SoilBiotics **DgradeR** on several of his acres in the spring of 2025. As the crop came up, he noticed that all his acres where he did not apply **DgradeR**, had chemical carry over from the previous year. Where he applied **DgradeR**, there was minimal if any indication of chemical carry over. This visual representation solidified his belief in the technology SoilBiotics has provided for us.

Another Indiana customer added **Growth Supplement 30** to his herbicide/foiar pass this spring. His weeds were extremely heavy and tall. In his words "Those weeds were starting to wilt about 2 hours after I sprayed."
